Data Sharing/Schools, Tribes

1. **Purpose:**

Contract with the Washington State School Directors' Association (WSSDA) to develop, in collaboration with tribes, a model policy and procedure to establish data sharing agreements between school districts and local tribes by January 1, 2021.

2. **Description of services provided:**

A model policy and procedure to establish data sharing agreements between school districts and local tribes was developed in consultation with the Office of Superintendent of Public Instruction's Office of Native Education, the Tribal Leaders Congress on Education, and local tribes; and reviewing model agreements developed by the Bureau of Indian Education and national Native education organizations. The model [data sharing policy](#) and [form](#) (memorandum of understanding/agreement) are housed on the WSSDA website.
