Kaabōnōnōik ak ba naan ko renana ak kōmman wewen ko retton ej juōn manit im armij eo ej jab kōnaan ak kōtloke ak wewen konono ak makitkit eo im ej kwalok kin an juon kōnaan bed iben ak babu iben bar juon (sexual) ñe:

- ♦ Juon ej kajioñ kōmman bwe juon rijikul ak rijerbal en lōmnak bwe ej aikuij kōtlok an armij eo kabōnōnōiki ak ba naan ko renana ak kōmman wewen ko retton ñane bwe en tobrak men eo ej kajitoke ak kōttobare, einwōt grade eo an, lelōñlok ilo jikin jerbal (promotion), bed ilo kumi in iukkure eo, ak jabdrewot bebe ak jemlok ko an jikul ak jikin jerbal eo, ak
- ♦ Manit eo elikkun kokkure an rijikul eo kōmmani katak ko an ilo jikul, ak ekōmman juon mejatoto in mijak ak mejatoto eo enana ilo jikul eo ak jikin jerbal eo.

- ♦ Kōmman kōjak kōn naan ko renana, arōk naan ilo wāween eo enana, ak kaabōnōnōki ro jet kōn naan ko renana
- ♦ Manman, ekoba ippān latipñōl ak babu ippān eo ejab kōnan (rape), im manman ilo iien eo pād ippān doon (sexual assault)
