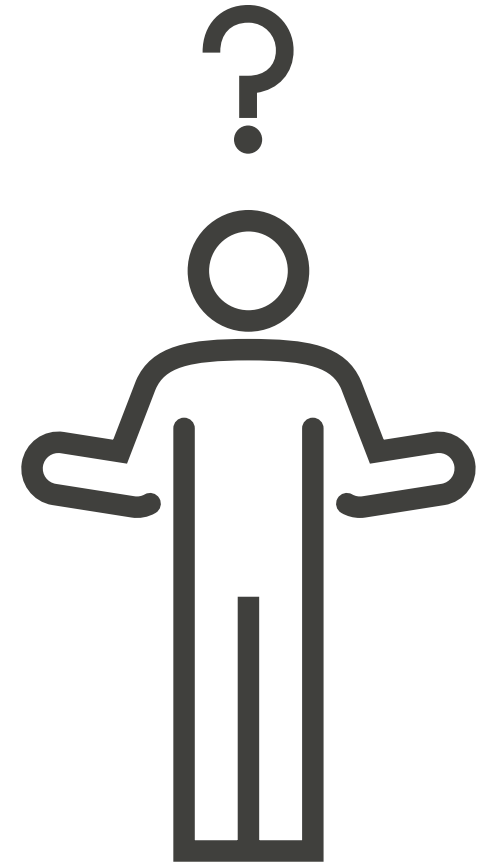

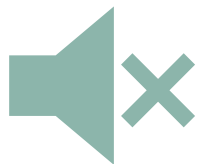

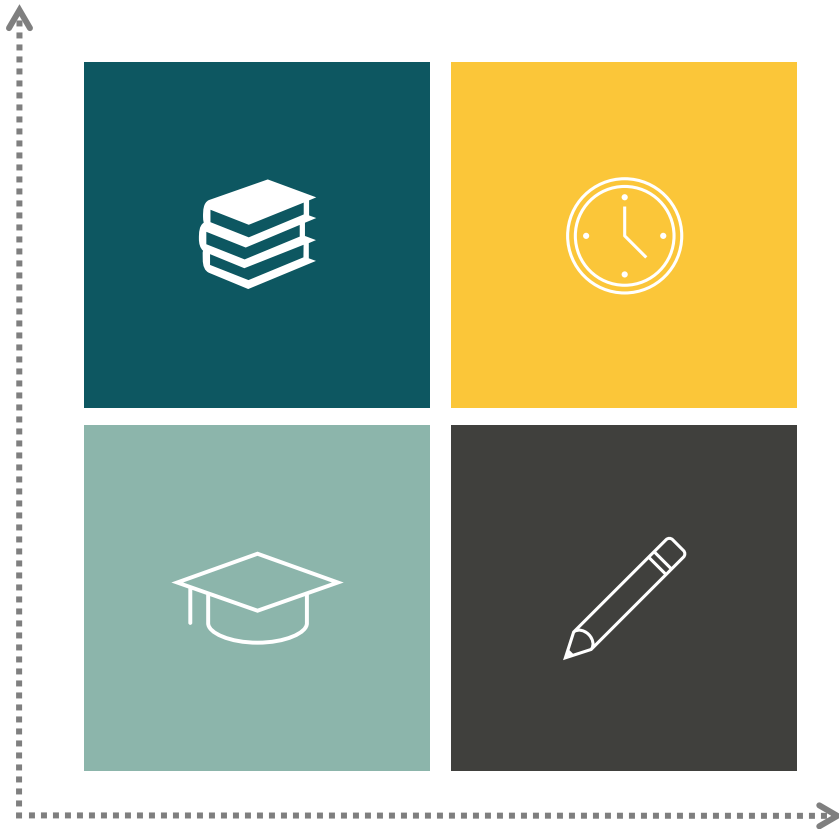


OSPI Office of Native Education/Resources

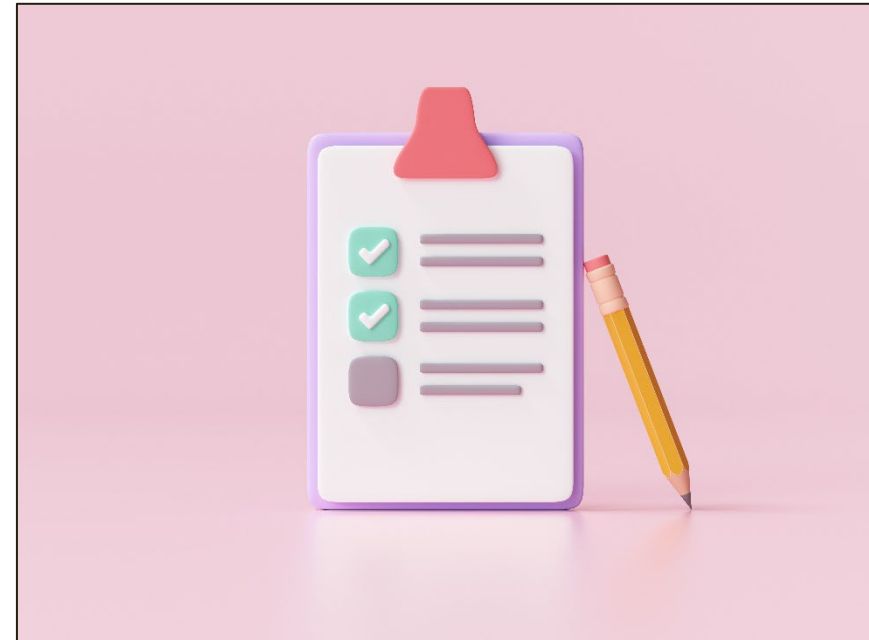
CTE Program Approval Bulletin

- This bulletin provides an update to the CTE Program Approval Process typically due to be completed in January for CTE courses to be approved and eligible for enhanced funding for the 2024–25 school year
- In response to feedback from Local Education Agencies (LEAs), with acknowledgement of our state administrative requirements, and in alignment with our agency expectation of continuous improvement, we will not launch the Office of Superintendent of Public Instruction (OSPI) EDS Based CTE Application Program Approval system
