Sec. 5003	Small District Modernization Grant Program. Provides fully funded capital grants for school building repairs and modernizations to school districts with enrollments of one thousand students or less.	\$114.8 M
Sec. 5004	School District Health & Safety Grants	\$8.1 M
Sec. 5005	Healthy Kids and Healthy Schools grants for capital projects that are consistent with the healthiest next generation priorities. Includes physical health and nutrition grants. Also includes lead/water testing.	\$1.5 M
Sec. 5007	School District Indoor Air Quality & Energy Efficiency. Grants for school districts to improve classroom and school building air quality through filtration enhancements, air quality improvements, and HVAC repairs/replacements.	\$45 M
Sec. 5008	School District Energy Assessment Grants. School District Energy Assessment Grants. This grant program will fund an American Society of Heating, Refrigeration, and Air-Conditioning Engineers (ASHRAE) Level 2 audit from a certified energy auditor to help prepare school districts for Clean Buildings Performance Standards requirements.	\$5.4 M
Sec. 5009	School-Based Health & Behavioral Health Clinics.	\$2.1 M
Sec. 5010	Career & Technical Education Projects. Funding for state skills center capital projects. Skills centers provide students with hands on learning environments relevant to current industries.	\$68 M

Sec. 5012	Distressed Schools. Grants to school districts with demonstrated facility issues.	\$10.4 M
Sec. 5013	SCAP Enhancement. Increases SCAP's construction cost allocation, the amount of funding awarded per square foot of new school construction, from \$271 to \$375 per square foot.	\$103.9 M
