Immigrants in the Workplace (2SSB 5497)

1. **Purpose:**

Funding was provided solely to support the activities associated with 2SSB 5497, from the 2019 legislative session. The funding provided in the proviso of \$63,000 for state fiscal year 2020 and \$7,000 for state fiscal year 2021 was to be used for the purpose of reimbursing the Attorney General for their services in advising OSPI on our confidentiality policies.

2. **Description of services provided:**

The proviso appropriated funding to be used to pay legal services provided by the State Attorney General’s Office for issues related to this specific bill. As noted in our fiscal note on the bill, OSPI updates policies on an as-needed basis within existing resources. The proviso amount was based on the Attorney General’s estimate of potential impact to OSPI. During SFY 21, the Attorney General invoiced OSPI \$5,128 for costs specifically related to 2SSB 5497. These costs were paid out of OSPI’s Central Services allocation for AG costs (General Fund-State) and were not charged to the proviso funds.
