 - This program is starting its 10th year.
 - Reviewed their theory of change, team leadership, residency experience, mentor experience, and impact.

 - Karen DeMoss shared out about Bank Street College of Education
 - Focuses on sustainability
 - This program has been around for 6 years
 - About 30 partnerships
 - This program uses the 3'Rs, Reallocation, Reductions, and Reinvestment
 - Reviewed the 5 Domains for Teacher Preparation Transformation
 - Reviewed the cost to WA state for first year teachers that aren't returning.
 - Reviewed Expected / Documented Residency Benefits in addition to diversity and turnover
 - Nick Gillion introduced the fourth and last speaker, Matthew Miller, Woodring College Western Washington University
 - Matthew Miller shared the outcomes from the Woodring College Western Washington University and then looped back to how they made those outcomes occur.
