Overview

Learning objects are autonomous blocks of educational content aligned to specific national or state standards that are presented in multiple modalities, such as instructional text, videos, games, or other online and offline activities. Several learning objects are presented together as lessons. This framework gives students multiple ways to engage with, understand, and demonstrate their mastery of the content. The multimodal approach offers various activities to a deeper understanding of the content. The courses include engaging online interactions such as drag-and-drop activities, matching exercises, and online games, along with the traditional text-based curriculum. Our courses fill the following needs:

- Credit Recovery for students who have taken a class but have not met all the standards for a course. Students that did not receive credit.
- Credit advancement courses for students desiring to obtain credit while enrolled full time in brick and mortar school.
