Habraaca Loo Maareyo Cabashooyinka Takoorka

1. Cabashooyinka takoorka waa in lagu xereeyaa 180 maalmood gudahood takoorka lagu eedeeyay.
2. Cabashooyinka takoorka waa in la siiyaa Madaxa Nafaqada ee Adeegyada Nafaqada Caruurta (Child Nutrition Services, CNS), Xafiiska Kormeeraha Waxbarashada Dadweynaha (Office of Superintendent of Public Instruction, OSPI). Sarkaalka Madaxa Nafaqada ayaa u gudbin doona Adeegga Cuntada & Nafaqada (Food & Nutrition Service, FNS), Xafiiska Gobolka Galbeedka, San Francisco.
3. Cabashooyinka takoorku waxay noqon karaan kuwa qoraal ama hadal ah. Isticmaalka foom loogama baahna qofka cabashada gudbinaya. Haddii qofku aanu doonayn, awood u lahayn, ama aanu jeclayn inuu cabashada qoraal ku qoro, qofka cabashada qaadaya waa inuu sidaas. (Foomka Cabashada ee ku lifaaqan.)

 - c. Sharaxaad ku saabsan fal gaar ah oo sababay in qofka cabanaya uu rumaysto in takooriddu ay tahay sabab.
 - d. Waxa uu ku salaynayo qofka cabanaya cabashada uu dareemayo in takoorku dhacay (isir, midab, wadan u dhalasho, jinsi (oo ay ku jiraan aqoonsiga jinsiga iyo nooca galmoodka), naafanimada, da'da, ama aargoosiga ama aargoosiga hawlihii hore ee xuquuqda madaniga ah).
 - e. Magacyo iyo jagooyinka, haddii la garanayo, iyo ciwaanada deegaanka dadka laga yaabo inay aqoon u leeyihiin falka takoorka ah.
 - f. Taariikhda(aha) ee falalka takoorka ah ayaa dhacay ama mudada falkan oo kale.
