Ewe Annukun Asukunen Aramas Kena fiti Terir Kena (Individuals with Disabilities Education Act, IDEA) seni 2004, usun ewe asukunen ren chon sukun kena fiti teririr kena, a kan mochen pwe sukun kena repwe ka awora ngonuk, ekkewe semen me inen emon chon sukun fiti ew terir, ika ra nuku pwe a angei ew terir, fiti ew arongorong a masow ren ew unusen awewen ren ekkewe pung ra kaworeno ngonuk me fan IDEA me pwan ewe U.S. Department of Education Code ren Annukun Federal (Code of Federal Regulations, CFR). Office of Superintendent of Public Instruction (OSPI) a kan nenemeni annukun state kena ra nemeni ewe kaworen ren sakonon asukun. Ekkei annuk ra kan kuuner non Chapter 392-172A Washington Akatowowun Code (Washington Administrative Code, WAC). Echo kaliin ei arongorong epwene kan ngonuk fan ew iteiten ierin sukun, me pwan: nupwen apoputan atotono ika eom tungor ren awukukuno; nupwen an ewe district we a angei eomuwe aewin nanengawen sakonon asukun seni nenien nonom non ew ierin sukun; nupwen an ewe district we angei eomuwe aewin foforan tungoren arongorong non ew ierin sukun; nupwen ew finata a kan forita ren ar repwene angei ew foforan amirit ina a kan pwarano pwe ew siwin ren iseisenong; me pwan nupwen ka tungor.

Eomuwe school district epwene kan awora ngonuk fiti poraus non maak usun auchean finata kena ina repwene ngaw ngeni an noum chon sukun we programen asukun. Ei ra kan aiita ngeni ew maaken

arongorong me mwan (prior written notice, PWN) me pwan a kan echo taropwe ina a kan pwarano finata kena ina ra kan forita non ew mwich ika seni ewe district non ponu ngeni ew tungor a forita senuk. **Ewe district epwene kan fofori an epwe tinngonuk ew maaken arongorong me mwan murin ew finata a kan fen forita, ngen me mwan foforinongan met ewe ra finata.** Ekkei ra kan finata kena ra kan riri ngeni aporaus kena ika ar rese mochen apopuweta ika siwini ewe aititinon, iseisenongan, ika kaworennon ren ew fichin asukunen meinisin ese momo (free appropriate public education, FAPE) ngeni noumuwe semirit.

Amumuta a wewen pwe:

Eomuwe suku district epwe kan fori ew eochun achochon ren an epwe angei eomuwe amumuta en ka sinei popun ren ew aewin awukuk ren ar repwe finata ika noumuwe semirit a kan nafeno ren sakonon asukun.

Eom amumuta ren ew aewin awukuk ese kan wewen pwe en ka kan ngenir eom amumuta ren ewe district ren an epwene poputa ne awora konon asukun me pwan aninis kena ra riri ngeni, ngeni noumuwe semirit.

Ika pwe noumuwe semirit a kan tonong non sukunen meinisin ika en ka kan kuuta eom kopwe atononga noumuwe semirit non ew sukenen meinisin me pwan en kose kan mochen eom kopwe awora amumuta, ika en kose kan ponu ngeni ew tungor ren eom kopwe awora amumuta ren ew apoputan awukukun, nge ina mo pwe kosapw kan fofori, eomuwe district **epwene** sotuni an epwe angei eom amumuta seni eae an amwich fengen ika fori ren foforan atetenin foforan arongorong kena, usun a kan kapas usun murin non ei arongorong.
