

What is a compliance coordinator?

Each school district is required to designate at least one employee to be responsible for monitoring and coordinating the district’s compliance with state and federal nondiscrimination laws.

- **State Compliance Coordinator:** The employee responsible for ensuring that the school district does not discriminate on the basis of sex, race, creed, religion, color, national origin, age, veteran or military status, sexual orientation including gender expression or identity, disability, or the use of a trained dog guide or service animal by a person with a disability (chapters [28A.640](#) and [28A.642](#) RCW, and chapter [392-190](#) WAC).
- **Title IX Officer:** The employee responsible for ensuring that the school district does not discriminate on the basis of sex, under Title IX of the Education Amendments of 1972 ([34 C.F.R. 106.8](#)).
- **Section 504/ADA Coordinator:** The employee responsible for ensuring that the school district does not discriminate on the basis of disability under Section 504 of the Rehabilitation Act of 1973 ([34 C.F.R. §104.7](#)) and the Americans with Disabilities Act ([35 C.F.R. Part 107](#)).

When should students, parents, employees, and others contact their school district’s compliance coordinator?

Students, parents, employees, and others should contact their school district’s compliance coordinator to report and resolve concerns of discrimination, or to file a [complaint of unlawful discrimination](#). The district’s Title IX Officer may be most effective in resolving concerns of sex discrimination or sexual harassment. The district’s Section 504/ADA Coordinator should be contacted for concerns of disability discrimination, including issues regarding Section 504 or accessibility. All other concerns of discrimination related to sex, race, creed, religion, color, national origin, age, veteran or military status, sexual orientation including gender expression or identity, disability, or the use of a trained dog guide or service animal by a person with a disability should be directed to the district’s State Compliance Coordinator.
