COMES NOW the Office of Superintendent of Public Instruction (OSPI), under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby revoke the Washington Education Certificate, No. 286192J, of Harvey Billmaier, based on the Findings of Fact and Conclusions of Law set forth below:

FINDINGS OF FACT

1. Harvey Billmaier was issued a Washington Education Certificate, No. 286192J, on August 8, 1988. That certificate currently remains valid.

2. Harvey Billmaier was employed by the Hoquiam School District.

3. On June 16, 2006, the Office of Professional Practices, within OSPI, received a complaint letter alleging a lack of good moral character or personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 181-87, by Harvey Billmaier.

4. During the 2005-2006 school year, Mr. Billmaier used Hoquiam School District computer equipment to access and view websites that contained sexually explicit images.

5. On May 24, 2006, Mr. Billmaier's office computer was observed accessing websites with inappropriate content.

6. During the 2005-2006 school year, while viewing pornographic websites, Mr. Billmaier showed sexually explicit images to B.B, a 17 year old student. Mr. Billmaier also discussed his "soft porn" movie business and told B.B. that he (Mr. Billmaier) could get him in the movies when he turned 18.

7. On May 26, 2006, Mr. Billmaier was placed on Paid Administrative Leave Pending Investigation.

8. On March 14, 2006, Mr. Billmaier resigned from the Hoquiam School District.

9. On August 8, 2006, Mr. Billmaier applied for Teacher Certification with the State of Alaska. On the Alaska Application for Certification, Mr. Billmaier intentionally omitted his teaching experience at Hoquiam School District, and denied any ongoing investigation with OSPI.

10. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Harvey Billmaier and over the subject matter of this action.

2. OSPI has shown by clear and convincing evidence, that the Washington Education Certificate, No. 286192J, of Harvey Billmaier, should be revoked as provided for in WAC 181-86-075.

3. Harvey Billmaier has violated: WAC 181-87, RCW 28A.410.090, WAC 181-86-013, WAC 180-86-014.
