COMES NOW the Office of Superintendent of Public Instruction (OSPI), under the authority granted by the laws of the state of Washington, having reviewed the file of the above-referenced case, and having considered the entire evidence contained therein, does hereby revoke the Washington Education Certificate, No. 397262G, of Neil Grenning, based on the Findings of Fact and Conclusions of Law set forth below:

### FINDINGS OF FACT

1. Neil Grenning was issued a Washington Education Certificate, No. 397262G, on April 4, 2002. That certificate currently remains valid.
  
2. Neil Grenning was employed by the Tacoma School District.
  
3. On April 8, 2002, the Office of Professional Practices, within OSPI, received a complaint letter alleging a lack of good moral character or personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 180-87, by Neil Grenning.

ORDER OF REVOCATION

4. Neil Grenning caused minor children to engage in sexually explicit conduct, knowing that such conduct would be photographed, between April 1, 2001 and March 3, 2002.
5. Neil Grenning had, or caused sexual relations with a minor child under twelve years of age between April 1, 2002 and September 30, 2002.
6. Neil Grenning sexually assaulted a minor child under twelve years of age, between April 1, 2002 and September 30, 2002.
7. Neil Grenning possessed multiple images of child pornography.
5. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

#### CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Neil Grenning and over the subject matter of this action.
2. OSPI has shown by clear and convincing evidence, that the Washington Education Certificate, No. 397262G, of Neil Grenning, should be revoked as provided for in WAC 180-86-075.


3. Neil Grenning has violated RCW 28A.410.090, WAC 180-86-013, and WAC 180-86-014.

**ORDER**

THEREFORE, it is hereby ordered that the Washington Education Certificate, No. 297262G of Neil Grenning, be revoked.
