PROPOSED FINAL ORDER
OF REVOCATION

COMES NOW Lin Douglas, the Informal Review Officer of the Superintendent of Public Instruction, having reviewed the files of the above-referenced case, and having considered the arguments of each party and the recommendation of the Admissions and Professional Conduct Advisory Committee, does hereby revoke the education certificate of Rodger L. Huckabee, Sr., based on the Findings of Fact and Conclusions of Law set forth below:

FINDINGS OF FACT

1. Rodger L. Huckabee, Sr. was issued a Washington Continuing Teaching Certificate, No. 306473J, on May 10, 1991. That certificate currently remains valid.
2. Rodger L. Huckabee, Sr. was employed by the Quilcene School District.
3. On August 20, 2000, the Office of Professional Practices, within OSPI, received a complaint letter alleging a lack of good moral character or personal fitness, or a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) 180-87, and/or the Revised Code of Washington (RCW) by Rodger L. Huckabee, Sr.
4. During the 1999-2000 school year Rodger L. Huckabee, Sr. visited numerous pornographic sites on the Internet during his classroom instruction time.
5. One student observed a pornographic site Rodger L. Huckabee, Sr. was viewing during classroom instruction time.
6. Rodger L. Huckabee, Sr. submitted a letter of resignation, dated April 18, 2000, to the Quilcene School Board, Superintendent and Principal.
7. Good moral character and personal fitness is a continuing requirement to maintain a Washington Education Certificate.

CONCLUSIONS OF LAW

1. OSPI has jurisdiction over Rodger L. Huckabee, Sr. and over the subject matter of this action.
2. OSPI has shown by clear and convincing evidence, that the Washington education certificate, No. 306473J, of Rodger L. Huckabee, Sr. should be revoked as provided for in WAC 180-86-075.

3. Rodger L. Huckabee, Sr. has violated WAC 180-86, WAC 180-87 and RCW 28A.410.090.

ORDER

THEREFORE, it is hereby proposed that the Washington education certificate, No. 306473J of Rodger L. Huckabee, Sr. be revoked.

This Proposed Order will become final thirty (30) calendar days from the date of receipt of this order unless respondent files an appeal for a formal hearing before the Office of Administrative Hearings.
