FINAL ORDER OF
REVOCATION

Thirty calendar days have transpired since the mailing to Juanita Jo Wolff of a Proposed Final Order of Revocation. Juanita Jo Wolff's failure to make a timely appeal of such order authorizes this agency to issue a Final Order of Revocation based on the Findings of Fact and Conclusions of Law set forth in the Proposed Final Order of Revocation. The following is hereby entered:

FINDINGS OF FACT

1. Juanita Jo Wolff was issued a Washington Education Certificate, No. 2726341R, on February 18, 1992.
2. Juanita Jo Wolff was employed by the Tacoma School District.
3. On June 11, 1999, the Office of Professional Practices, within OSPI, received a complaint letter alleging Juanita Jo Wolff may lack of good moral character or personal fitness, a violation of the Code of Professional Conduct, Washington Administrative Code (WAC) and the Revised Code of Washington.

4. In 1999, the Tacoma School district determined that Juanita Jo Wolff's teaching contract would not be renewed. The June of 1999, the Tacoma School District gave papers to that effect to a process server, Mr. Melvin Calhoon, so that Mr. Calhoon could serve the papers on Juanita Jo Wolff.

5. On June 3, 1999, Mr. Calhoon went to Juanita Jo Wolff's home and saw Ms. Wolff standing in her driveway. Mr. Calhoon explained who he was and that he had papers for Juanita Jo Wolff from the Tacoma School District.

6. Juanita Jo Wolff, who had a gun on her person, fired four shots at Mr. Calhoon's left tires. Ms. Wolff was arrested and charged with one charge of Assault in the Second Degree, a felony.

7. On August 11, 1999, in the Superior Court of the State of Washington, Juanita Jo Wolff was acquitted of one count of Assault in the Second Degree by reason of insanity.

Juanita Jo Wolff was then committed to the custody of the Secretary of the Department of Social and Health Services.

8. Good moral character and personal fitness is a continuing requirement to maintain a Washington education certificate.

CONCLUSIONS OF LAW


1. OSPI has jurisdiction over Juanita Jo Wolff and over the subject matter of this action.
2. OSPI has shown by clear and convincing evidence, that the Washington education certificate, No. 272341R, of Juanita Jo Wolff, should be revoked as provided for in WAC 180-86-075.
3. Juanita Jo Wolff has violated RCW 28A.410.090, WAC 180-86-013, and WAC 180-86-014.

ORDER

THEREFORE, it is hereby ordered that the Washington education certificate, No. 272341R, of Juanita Jo Wolff be revoked.
