IT IS HEREBY STIPULATED by and between the Office of Professional Practices of the Office of the Superintendent of Public Instruction, represented by W. Howard Fischer, Assistant Attorney General, and Forrest Lee Hudson, the above named respondent, represented by G. Saxon Rodgers, as follows:

1. The certificate(s) issued by the Superintendent of Public Instruction to Forest Lee Hudson, Certificate No. 199301C may be suspended for a period of twenty-one (21) months from and after the date of entry of this order; provided that, the respondent shall be credited for fifteen (15) months of said suspension;

2. The teaching certificate(s) issued by the Superintendent of Public Instruction, Certificate No. 199301C may thereafter be suspended for a minimum of six (6) months with reinstatement contingent upon receipt of a certification by Dr. Robert E. Sands that Forrest Lee Hudson does not suffer from any condition

1 which would impair his ability to serve as a certificated  
2 employee in the common schools;

3 3. The appeal of Forrest Lee Hudson from the Proposed Final  
4 Order of Suspension herein may be withdrawn.

ORDER

7 Based upon the above stipulations, and it appearing from a  
8 review of the files and records herein that the proposed  
9 disposition will deter future conduct and is in the public  
10 interest, now, therefore,

11 IT IS HEREBY ORDERED that the certificate(s) issued by the  
12 Superintendent of Public Instruction to Forrest Lee Hudson,  
13 Certificate No. 199301C, shall be and hereby is suspended for a  
14 period of twenty (21) months from and after the date of entry of  
15 this order; provided that the respondent shall be credited for  
16 fifteen (15) months of said suspension; and

17 IT IS FURTHER ORDERED that the certificate(s) issued by the  
18 Superintendent of Public Instruction to Forrest Lee Hudson shall  
19 be and hereby is, suspended for a minimum period of six (6)  
20 months with reinstatement contingent upon receipt of a  
21 certification by Dr. Robert E. Sands that Forrest Lee Hudson  
22 does not suffer from any condition which would impair his  
23 ability to serve as a certificated employee in the common
