I have not been, to the best of my knowledge, convicted of any felony crime listed within WAC 180-86-013(1).

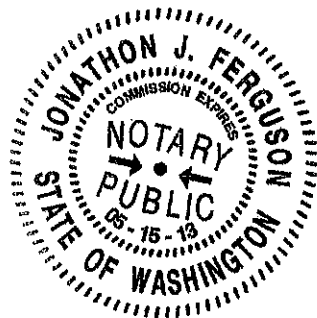
