HOW TO APPLY FOR AN ENDORSEMENT TO A WASHINGTON TEACHING CERTIFICATE

Step 1. Eligibility. To use this application you must hold a valid endorsed Washington teaching certificate.

Step 2. Application. Submit complete application and application fee, to include all applicable materials in the checklist below to one of the nine Educational Service Districts (ESDs) shown below. Do not send your application and fee to OSPI. OSPI is not authorized to collect fees. All certification fees are non-refundable.

Step 3. Certificate. When all requirements have been documented, the OSPI Certification office can issue a certificate with the requested endorsement added.

CHECKLIST [& REQUIREMENTS]. COMPLETE AND ATTACH THIS CHECKLIST AS A COVER SHEET.

- Application - Submit Form SPI/CERT 1522A, Application for an Endorsement.
Fee - Submit Fee Payment Schedule with payment.
Washington Certificate - Submit original teaching certificate so that it can be reissued with the added endorsement. The reissued certificate will bear the same dates as the original certificate. Adding an endorsement does not affect the validity of your certificate.

Plus one or more of the following:

- Program and WEST-E Test - Submit FORM SPI/CERT 1522E, Institutional Verification of Endorsement Program Completion and Character. [Must have completed a state-approved endorsement program at a regionally accredited college/university.]
WEST-E Test - [All applicants must pass a WEST-E test in the endorsement area] Submit an original WEST-E score report.
National Board Certificate - [May qualify by holding a valid certificate issued by the National Board for Professional Teaching Standards in a Washington endorsement area] Submit a copy of your National Board certificate.
WEST-E Test Alone - [May qualify in an area related to an endorsement already held.]
[Applicants for endorsement via testing must have 90 days of teaching experience in the related area you are currently endorsed.] Submit FORM SPI/CERT 1522F, Verification of Endorsement Experience.

Send all required materials following instructions in Step 2 above.

EXCERPTS FROM REGULATION [WAC 181-82A-204(2)]

(2) In order to add an additional endorsement, the candidate shall:

(a) Have completed a state-approved endorsement program which includes methodology (see WAC 181-78A-264(5)) and addresses all endorsement-specific competencies adopted by the professional educator standards board and published by the superintendent of public instruction. The requirement for field experience shall be at the discretion of the college/university. Provided, that in cases where programs require a field experience/internship, the colleges/universities should make every attempt to allow the individual to complete field-based requirements for the endorsement within the confines of the individual's teaching schedule; or

(b) Achieve National Board certification in a Washington teaching endorsement area and hold a valid National Board certificate; or

(c) Pass the subject knowledge test approved by the professional educator standards board for the certificate endorsement being sought. The instructional methodology and content-related skills of the desired subject endorsement must be compatible endorsements adopted by the state board of education and published by the superintendent of public instruction. The applicant must document a minimum of 90 days teaching experience, in a public or state approved private school, in the endorsement that is compatible in instructional methodology and content-related skills to the desired endorsement.

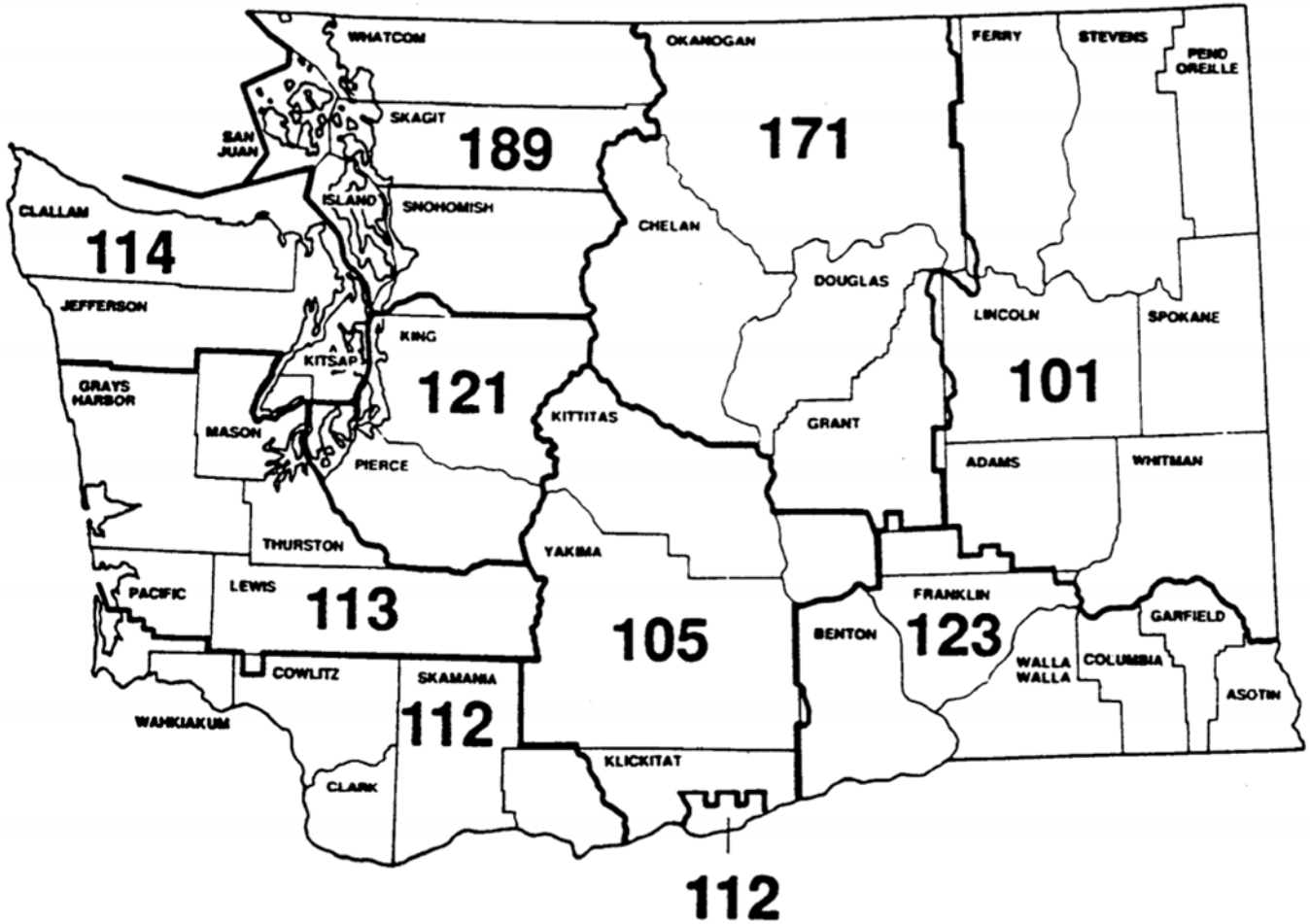
