2022 School District Accountability Appeal

School districts may submit a request to appeal a school(s)' identification as Tier 3 Plus, Tier 3, or Tier 2 based on one or more measures used to create the school's Washington School Improvement Framework (WSIF) Combined School Score. Reasons for an appeal include:

- (1) special or unique circumstances or events that may have impacted outcomes for groups of students or whole schools; or
- (2) inaccurate CEDARS data reporting. **Note**: To submit an appeal based on inaccurate CEDARS reporting, the district must first submit corrected CEDARS data to OSPI.¹

If the appeal is based on special circumstances and not related to inaccurate CEDARS data, the district should only submit this form. If OSPI approves the appeal for special circumstances, OSPI cannot recalculate the school's Combined School Score by removing the year/measure(s) impacted by the special circumstances. The school's publicly reported Combined School Score will not change because such a change would have impacts on other schools.
