## **Regional Safety Program Grants**

- 1. Purpose: Authorizing Legislation -ESSB 6032 Section 501(69) The purpose is to provide grants to Educational Service Districts and School Districts to develop or expand regional safety programs to address student safety. At a minimum, programs must implement a multitier threat assessment system; develop a process for notifying schools, including private schools, of safety emergencies; and make recommendations or implement appropriate safety technology consistent with regional need.
- 2. Two LEAD ESD's (ESD105 and ESD 114) were tasked with developing or expanding regional school safety programs to address student safety. The 2 LEAD ESDs received funds from this program to implement and collect regional data on district multitier threat assessment systems, work with districts to develop processes for notifying schools, including private schools, recommend appropriate safety technologies consistent with regional need, and assess regional comprehensive safety planning processes.

The seven other ESDs received funds from this program to collect data on current safety planning efforts, develop and implement district multitier threat assessment systems; work with districts to develop processes for notifying schools, including private schools, in the event of an emergency, recommend appropriate safety technologies consistent with regional need, and assess regional comprehensive safety planning processes.

3. To receive grant funding, each ESD completed the iGrant form package which was made available, including agreeing to the assurances therein.
