#### 7. Programmatic changes since inception (if any):

The pandemic dramatically changed school meals both in terms of the student experience and the administration of the programs.

The USDA provided over 100 waivers to help school meal programs respond to the pandemic. Two of the largest waivers allowed schools to operate universal free meals in SY 20-21 and now 21-22. Even though was CEP was temporarily not needed for universal meals, there was still a large increase in CEP schools.

## 8. Evaluations of program/major findings:

House Bill 2660 (2020) exacted a requirement to operate CEP if a school has an Identified Student Percentage of 62.5% or greater. All *Manded Schools* are either operating CEP or universal meals through a pandemic waivers from USDA. This was a major objective of the 2020 legislation and the following proviso.

82 new schools joined CEP before the 2020-21 School Year, making it the largest increase in many years.

Universal meals have become the norm during the pandemic, giving districts a trial run of what CEP would be like to operate with students at school. OSPI believes we will continue to see expanded growth in the coming years.

Potential federal legislation may also have substantial positive impacts on CEP, making it a possibility for many more schools statewide.

Budget: ESSB 5092 Section 1501(4)(x) - \$57,000 of the general fund state appropriation for fiscal year 2021 is provided solely for implementation of Engrossed Substitute House Bill No. 2660 (school meals at no cost). If the bill is not enacted by June 30, 2020, the amount provided in this subsection shall lapse.
