## **State Tribal Education Compacts**

- Purpose: Funding is provided to support the implementation of HB 1134 (2013 Session), State-Tribal Education Compact Schools.
- 2. Description of services provided: One additional Tribal Education Compact School (Chief Leschi) has joined the current five Tribal Education Compact Schools (Chief Kitsap Academy, Lummi Nation Schools, Muckleshoot Tribal School, Wa He Lut Indian School, and Quileute Tribal School). All have been integrated into the SAFS data system. Applications which needed to accommodate tribal compact education schools at the beginning of the school year included the apportionment system and the enrollment reporting system. The Office of Native Education staff, met with a number of tribes during the year to provide information on the process to become a Tribal Compact School. Due to one (1) Tribal leadership request to place their respective request onhold until the summer of 2019, the Yakima Nation Tribal School was approved to be included in the 2019-20 school year.
- Criteria for receiving services and/or grants: Only Tribal schools may enter into a Tribal Education Compact School agreement with OSPI. The Compact includes Assurances that must be signed by Tribal leadership in order to participate.

- 7. Programmatic changes since inception (if any): No program changes were made.
- 8. Evaluations of program/major findings: Program evaluations were not required under the law. However, the anecdotal data suggests that the Tribal Education Compact Schools have seen an increase of students participating as the schools are considered safe environments for the Native students they serve.
- 9. Major challenges faced by the program: Acquiring certificated staff that are willing to remain as a teacher or principal for longer than one or two years has been a challenge. This is especially true for teachers of students with disabilities.
- 10. Future opportunities: The future holds great promise because Native students have access to federal/state programs and services that they may have not had access to in the past.
- 11. Statutory and/or Budget language:

Budget Proviso: SSB 5883 Sec. 501(15) - \$14,000 of the general fund--state appropriation for fiscal year 2018 and \$14,000 of the general fund-state appropriation for fiscal 2019 are provided solely for implementation of chapter 242, Laws of 2013 (state tribal education compacts).
