Welcome and Introductions - Andrea Cobb, Executive Director of the Center for the Improvement of Student Learning (CISL), OSPI and Emily Rang, Director of Data Governance, OSPI

Race and Ethnicity Task Force – Data Protocols and Guidance - Emily Rang, Director of Data Governance, OSPI Emily revisited the RCW and asked for feedback about next steps to convene a group to draft material.

K-12 Data Governance Reorganization and Planning - Emily Rang, Director of Data Governance, OSPI

- Emily reviewed the group's charge and objectives, and shared a draft data flow chart as well as a draft operations and support layers diagram.
- Superintendent Reykdal visited with the group and reminded everyone that expectations are going to grow for OSPI to produce answers, encouraged the group to ask and anticipate hard questions, and reiterated that districts need to see the value in what they're asked to do, so providing tools to empower them is needed.
- Group discussion regarding not only the need for districts to see value, but for this group to recognize that as we ask districts to report more data, districts need more highly skilled people to do the work.
- Group feedback regarding membership and reorganization largely suggested more participation from Educational Service Districts, additional schools and districts of varying sizes, including representatives from all data domains, possibly adding community-based organizations, and that broadly advertising this group would be possible ways to obtain additional engaged members.
- The creation of a work plan and meeting calendar with standard agenda items was suggested and will be
 drafted by Emily to help bring clarity to who should be participating in these meetings from the existing
 or added organizations in the future.
- Additional feedback or suggestions on improving or clarifying membership roles and member organizations were solicited by Emily.

- Karen Pyle, ERDC, shared that CEDARS data is now loaded into a data warehouse and can produce quick data sets as requested.
- Arina Gertseva shared that the Washington State Center for Court Research has been looking at
 educational outcomes of students who were in county juvenile justice systems and are now looking at
 the correlation between court cases and educational outcomes. They are also looking at risk factors and
 will be publishing these findings within the next few months.
- Cheryl Ricevuto shared that the Legislature is providing funding for PESB to partner with ERDC to get individual-level data.
- Dr. Min Sun discussed her Education Policy Analytics work at UW, which has an emphasis on educator quality and teacher diversity.
