## American Affairs - Toshiko Hasegawa and Isa Whalen

- Established 1974, Renamed 1995
- Mission: To improve the lives of community members by promoting access
- 12 appointed commissioners, appointed by Governor.
- 2023-2026 Strategic Plan
  - Civil Rights & Immigration
  - Economic Development
  - Access to Democracy
  - o "AANHPI" Asian American, Native Hawaiian, and Pacific Islander
  - COFA Lobby Day
  - ANHPI Heritage Month
- Appointing Group for State Committees, Task Forces, Workgroups
- 2020 Demographic Report 12.64% of WA population
  - Aims to equip agencies with most applicable data
  - Community involvement jumped between 2018 2021
  - Bystander Resources
- Isa Whalen Appointed Representative AANHPI
  - Isa surveyed youth in WA state regarding the following topics:



- When you think of School Safety and Student Well Being, what comes to mind
  - Fear of gun violence
    - Campus police benefit
  - Lack of Counselors
- What practices do you see working
  - Mentorship & guidance, Having knowledge, training or resources
  - Physical spaces
  - Ethnic Studies curricula
    - Need for Oceania and Pacific Islander Studies
- What work needs to be done
  - Hire and increase capacity for counselors
  - Have designated spaces for diverse racial/ethnic organizations
    - Move away from "office of minority affairs"
  - Resources are abundant in urban communities, need more in rural communities
  - Changing the narrative story telling, experiences, etc.
- Possible Solutions
  - Disaggregated data to empower NHPIs
  - Professional development
  - Retainment
    - Parent Advocacy
- Intentionality with terms and guidelines
- Community Ask: MakeUsVisible legislation for Asian American Studies in K-12 Schools

  - Chicano & Mexican leader lobbies Governor Evans
  - Name changes in 80's
  - Staff: 3
  - Commissioners: 11
- Mission: Identify & define issues
- Advise the Governor and state agencies
- Advise the Legislature on issues
- 13.7% largest minoritized community
  - o 1.08M
- 24.65% of student population in K-12 system

## **Re-engagement and Restorative Practices**

- Facilitated by Kamrica Ary-Turner AWSP
- Restorative & Re-Engagement Strategies
  - Derived from Criminal Justice Reform
    - Building relationships
    - Community Agreements
    - Strives to respect all parties
    - Provide opportunity for equitable dialogue and decision making
    - Involves relevant participants
    - Addresses harms, needs, obligations
    - Encourages all to take responsibility
  - Shift in Mindset in punitive restorative practices
    - Principals and staff need guidance and solutions
    - For students "how are we supporting you to be your best self?"
  - Shift in language
  - 3 Tier Approach to restorative practices
    - Tier 1 Restorative school climate
    - Tier 2 Restorative discipline
    - Tier 3 Re-entry and restorative healing
- Re-engagement Practices the 4 R's
  - Reflecting



- Redirecting
- Reminding
- o Reinforcing
- Whole School Tips
  - Daily or weekly morning meeting (SEL Check-In)
  - Goal setting (academic or behavioral)
  - Allow the student who was harmed to share what the harm made them feel to the offender
  - Create Learning Lab
- Process of Restorative Practices for Teachers
  - Build relationships with students
  - Learning Lab interventions
  - Communicate Home
  - Reach out to School Community for support
  - Document with intent to communicate
  - Complete student management entry
  - Participate in Re-entry
  - Follow up with the student
  - Consistent Communication Home
  - Keep students team informed
- Leadership Moves Re-Engagement Process
  - Communicate with students family/guardian
  - Identify staff support team
  - Restorative circle classroom (as needed)
  - Restorative circle with teaching team (as needed)
  - Meet with student who caused harm
  - Meet with student who received harm
  - Conduct restorative meeting with students (as needed)
  - Follow up plan
  - Communication is key

# **Restraint and Isolation -** Facilitated by Lee Collyer - OSPI

- What is a Restraint?
  - Restraint as defined in RCW 28A.600.485 means: Physical intervention or force used to control a student
- What is Isolation?
  - o Restricting a student alone in a room or enclosure in which the child cannot leave
    - This practice is dangerous for children. Can inhibit brain development
- Number of Incidents in 2020 25,415
- Number of Students Restrained 3,825
- Denying them education
- Restraint and Isolation are Equity Issues. External Controls
  - Most affected are Students with Disabilities and Black/African American Students
    - Grade K-5 80%
    - Grade 6-8 10%
    - Grade 9-12 10%
  - Cause more harm than it fixes
  - Students don't learn this way
- Restraint and Isolation in the News
  - US DOJ Settlements involving isolation
- Crisis Response Workgroup
  - o Specific members required
- Crisis Response Programs
  - Recommendations
    - Increase educator training of De-escalation Practices
    - Improve Data Collection
    - Eliminate
- SHB 1479 would ban the use of isolation, chemical and mechanical restraint for all students in WA by August 1, 2025
  - Clarifies definitions
  - Protects continued use of "quiet rooms"
  - o Improves reporting requirements
  - Preserves restraint in instances of imminent likelihood of serious harm
  - Increases Technical assistance
  - Provided professional development
  - o Improves School Board knowledge and oversight
  - Cannot take away without providing a new method

- Inclusivity in School Culture Non Academics
  - What's the Problem
    - Brings sense of competition
    - School culture often associated with sporting events, clubs, pep rallies
      - Does not appeal to all students
  - Statistics and Equity
    - 1 in 3 students rate their school positively (33%)
    - Based on gender
    - Feeling like discipline is fair
      - 39% white students
      - 28% Black/African American
  - Solutions
    - Collaborations
    - Awareness
    - Strategies
