PURPOSE/BACKGROUND

The Office of Superintendent of Public Instruction (OSPI) filed <u>CR-103E</u> to establish the Transition to Kindergarten (TK) program for the 2023–24 school year, as directed by <u>SHB 1550</u>, passed by the Washington State Legislature in 2023. OSPI will also conduct permanent rulemaking concerning TK programs. The permanent rules are anticipated to be effective by the 2024–25 school year.

This bulletin is intended to provide information about Chapter 392-425 WAC and guidance for local education agencies (LEAs) implementing a TK program. Additional guiding documents will be posted to the OSPI website.

SUMMARY OF THE EMERGENCY RULES

The emergency rules were effective August 1, 2023, and establish expectations and requirements for LEAs in implementing and administering TK programs for the 2023–24 school year. The emergency rules are posted on the <u>OSPI website</u>, and include:

Purpose and Authority

Authorizes OSPI to establish rules related to TK.

Eligible LEAs

Clarifies the LEAs authorized to implement a TK program during the 2023–24 school year.

Notification of Intent to Offer a TK Program

Any local education agency intending to offer TK during the 2023–24 school year must notify OSPI by completing the <u>2023–24 TK Assessment Profile</u> located on the OSPI website.

Early Learning Coordination

All LEAs offering a TK program must make a best effort to coordinate with local child care and early learning providers. Resources and guidance for coordinated recruitment and enrollment are located on the OSPI website.

Staff Qualifications

TK teachers must hold a valid teaching certificate; endorsement in early childhood education is strongly recommended.

Student Eligibility

Clarifies the criteria for TK eligibility and establishes parameters for priority and enrollment policies. TK is a program for children who are at least 4 years old by August 31st; and have been determined, through a screening process and tool, to need additional preparation to be successful in kindergarten the following year. Restricts LEAs from charging tuition for enrollment in a TK program.

Minimum Instructional Requirements

TK programs must be offered during the school year and as an all-day program. Families may choose to enroll a student for a partial day.

Assessment

All three components of the Washington Kindergarten Inventory of Developing Skills (WaKIDS) must be administered at the beginning of the program. It is recommended that the WaKIDS Whole-child Assessment be administered one more time prior to the end of the school year.
