Group Discussion Summary (missed group 1's sharing)

Resources that would benefit districts right now, depending on size of district

Means to share on what other districts are doing and what is working and what is not working to support students or reengagement.

More info how to blend and braid funds.

Shifting needs for this political moment – resources for conversation for some of our political issues and how to support our parents/staff, etc.

How to keep that communication positive and continue to support students positively.

What we can do support reengagement.

Beneficial if OSPI would be involved in conversation more on how to handle some situations and targeted to the need.

Interest in communication from OSPI was helpful on things we didn't have to report on, possibly let districts know ahead of time to give us a heads up that may not be required.

Notifications on when form packages will be opened ahead of time.

Private schools need to submit data before spring break.

What kinds of things need to be electronic or original signature? Helpful what is a requirement from OSPI.

End of year report not working correctly knowing its now due till end of September.

WISP – some districts use that process, would be helpful to get that information sooner rather than later.

District sharing – monthly PLC's ran monthly, districts may want to share best practices connecting with private schools or integrating funds, a talk session may get a little more input.

Year at a glance, as much communication regarding timelines that may shift.

Have a casual conversation rather than presenting a presentation, less formal meetings.

Systems – is it possible to support us with taking a systemic approach. Create an infographic and housed on website with live links and resources. Family engagement – continue process of sharing practices to ensuring equity for our families.

Title /LAP programs – Regional meetings by Zoom focusing on best practices, database created where one topic might be models, another top could be assessment, and intervention another topic. Create a warehouse of what works for Title I/LAP.

Collaboration and coordination with other programs to work more efficiently with all programs.

Webinars with best practices or statewide share out.

PLC's that are targeted to share out their strategies and best practices.

Are the Science of Reading and strong instructional practices in all curricula in place?
