Senate Bill 6362 (2018) authorized increases in salaries for all state-funded school personnel, which includes school transportation personnel. While funding for the new salaries and associated benefits was provided for Fiscal Year (FY) 2019, the base budget does not include the increased costs for future years. This funding is requested to correct the maintenance level funding for school transportation to reflect the new salary and benefit levels approved by the Legislature in 2018.

### What is the problem, opportunity or priority you are addressing with the request?

The carryforward funding for pupil transportation does not include the compensation increases that were authorized by Senate Bill 6362 (2018) session. Funding for FY 2019 was provided in the supplemental appropriations bill, Senate Bill 6032 (2018).

## What is your proposed solution?

The funding in this request seeks to increase the program budget for pupil transportation (Senate Bill 6032, Sec. 504 [2018]) by \$102,000,000 per year for future biennia.

# What are you purchasing and how does it solve the problem?

The funding in this request will provide funding to pay for statutorily mandated salaries for school district personnel who support pupil transportation operations.

### What alternatives did you explore and why was this option chosen?

Without additional funding, school transportation personnel will receive salary increases for fiscal year 2019 only.

The funding in this request is based on the funding provided for FY 2019 in the supplemental appropriations bill, Senate Bill 6032 (2018).
