Students are expected to have regular synchronous communications with their teachers. At a minimum, all students enrolled in Pearson Virtual Schools online courses in Washington will interact (e.g., via phone, chat, LiveLesson® session, or other approved communication channels) with either their Pearson Virtual Schools or regular school teacher at least every week. Responsibility for student progress monitoring and contacts is a shared responsibility between the Pearson Virtual Schools teachers and the partnering school/district teachers, ensuring that all students have regular weekly contact with a teacher to support their learning and academic success.
