Due Process, Litigation, and PESB updates

Pre-endorsement

OSEP reminded ongoing shortages that were also impacted by the pandemic and continue to struggle to find special education staff, don't go too far with waivers and alternate routes. Special education certification cannot be waived for the provision of special education services, and that alternate routes to special education certification can only be for a period of three years.

Consensus with PESB that the pre-endorsement waiver meets the criteria for an alternate route. It just has the unfortunate use of Waiver in the title. PESB and Special Education are working on relabeling the form and changing the pre-endorsement waiver from five-year endorsement to a three-year endorsement.

Debrief Community Forum

• Topic(s):

- What went well? Focus groups were created and were successful.
- Concerns and questions.
 - Parents were frustrated with not knowing their rights and did not have a clear pathway to connect with other families. And feeling a disconnect with OSPI and their rights. Hesitancy to go to OSPI when they had concerns because they did not want to be 'that' parent and negatively impact the school's relationship with their child.
 - The questions that WESTED crafted did not seem to be focused on the audience. And yet one community member believed this to be one of the more empowering activities in which they have participated.
 - More advocacy is needed. We can have all the laws and we have all the policies and helping parents navigate in a meaningful way is especially important.
 - Many participants asked if there were going to be future opportunities such as this forum.
- o Send WESTED/NCSI follow-up from the forum.
 - WESTED/NCSI will set up a debrief with Tania, as they are committed to making sure this is a co-designed effort. They are open to feedback about the process.
 - They are starting work with OSPI SpEd to set up an equity team that will include some participants from focus groups.
