Dear Ms. Whalen:

I am writing to request a waiver, pursuant to section 8401(b) of the Every Student Succeeds Act (ESSA), of section 1111(b)(3)(C)(ii) of the Elementary and Secondary Education Act of 1965 (ESEA), as amended by the No Child Left Behind Act of 2001 (NCLB), that Washington's assessment system measure the full range of the state's academic content standards. As part of its *Washington State K-12 ELA Learning Standards*, Washington measures the assessable elements of its listening standards. Washington, however, is not yet ready to measure some elements of the standards included in the speaking and listening strand. Washington, therefore requests this waiver only with respect to measuring the content in the state's speaking and listening strand that is not otherwise currently assessed by the state. Washington requests this waiver because it is not practicable at this time for Washington to administer a large-scale summative assessment that includes measures of the full range of the standards included in the speaking and listening strand. This waiver will advance student achievement by permitting Washington to have a valid and reliable assessment system that measures the full range of the rest of the state's academic content standards while providing time to complete the work necessary to have a valid and reliable measure of the full range of the standards included in the speaking and listening strand.

Washington requests this waiver to allow for continued state and local receipt of Title I, Part A funding in good standing while Washington completes additional work to develop accurate, valid, reliable, and instructionally useful assessments related to additional content within the speaking and listening strand. This waiver is requested for the 2015–16 through the 2016–17 school years. Washington assures that, if it is granted the requested waiver:

- It will continue to meet all other requirements of section 1111(b)(3) of the ESEA, as amended by NCLB, and implementing regulations with respect to all state-determined academic content standards and assessments, including reporting student achievement and school performance, disaggregated by subgroups, to parents and the public.
- It will continue to work toward assessing additional content within the speaking and listening strand consistent with the state's academic content standards.

I support the limited waiver request through SY1617 not to assess the full breadth of the speaking and listening strand within the adopted ELA standards. As a member state of the Smarter Balanced Assessment Consortium, Washington has demonstrated progress towards assessing speaking and listening standards in sophisticated and innovative ways far exceeding prior state assessments (where listening wasn't ever assessed at all). An opportunity to extend the waiver beyond the SY1617 would also be appreciated to ensure appropriate and comprehensive assessments and the infrastructure to operationalize the assessments at the school and classroom level.
