CTE Updates: Career Preparation & Launch Grant

- FP 277: Competitive grant to school districts to purchase and install CTE equipment that expands career connected learning and work integrated learning opportunities

CTE Verification Report: Background/Purpose



Local Education Agencies (LEAs) must ensure that Career and Technical Education (CTE) courses and programs are approved pursuant to requirements authorized by Revised Code of Washington (RCW) <u>28A.700.010</u> in order to be eligible for <u>state CTE enhanced funding</u>.




As the Office of Superintendent of Public Instruction (OSPI) continues to evaluate and restructure state-level systems for approving CTE programs, we are issuing verification reports to support districts, Skills Centers, and State-Tribal Education Compact schools to evaluate course eligibility for CTE enhanced funding and to support LEAs documentation of state CTE courses.



CTE Verification Reports: How did LEAs receive the report?

- Reports will be sent to LEA staff with the user role of CTE Director in the Educational Data System (EDS) late September to early October 2023. If you do not already have access in EDS, please contact your District Data Security Manager (DDSM) to assign you the "CTE Director" role.
- Reports will be sent through the Alchemer Survey Tool via email notification from noreply@alchemer.com with Subject Line: OSPI CTE Course Verification Report (2023–24).

CTE Verification Reports: What do the colors mean?

None:

No action is required; LEA maintains course approval or program approval signature page on file.

None/Info Only:

No action is required; LEA may find information useful when cross-checking current course approval.

Action Required:

LEA must submit a new course approval application by November 17, 2023; review needs for reconciliation.

Action Requested:

LEA reviews course application to complete submission or delete the application if course is no longer valid.



CTE Verification Report: Example

White rows: complete app submission or delete if no longer valid.

Blue rows: No action is required; LEA may find information useful when cross-checking current course approval.

Red rows: carefully review to identify courses not approved for 2023–24 that require immediate action (guidance documents will be provided).



Green rows: Ensure approved courses in green include all CTE courses being offered during the 2023–24 school year, these are the only courses eligible for CTE enhanced funding.


CTE Verification Reports: How should LEAs respond to the report?

1. Carefully Review Each Row of the LEA Report to Determine Needed Actions: LEAs should utilize the supporting resource documents in reviewing and responding to the CTE Course Verification Report. The review's priority should be to ensure that any courses offered during the 2023–24 school year are reflected in green on the report as courses in good standing eligible for enhanced funding.

If a course is being offered in 2023–24, but NOT included in the green approved section of the verification report, a new course application must be submitted in the <u>Education Data System</u> (EDS) by **November 17, 2023.**

2. Complete the Survey: LEAs will be asked to verify receipt of the report by completing the survey embedded within the Alchemer correspondence by October 20, 2023. All LEA staff receiving the survey are encouraged to complete the survey; the CTE department will follow up with LEAs that do not respond.

Where is my report?

• All reports have been sent out as of September 29, 2023. They were sent from the email noreply@alchemer.com. If your LEA has not received the report, please check your junk mail. If it is not there, please email cte@k12.wa.us.

What is the purpose of these reports?

 Course Verification Reports are in support of LEAs review and confirmation that all courses claimed for enhanced CTE funding during the 2023–24 school year are approved in EDS, and further identifies all state-approved CTE courses by LEA. Utilizing the provided report, LEAs should carefully review each row for course-related data and follow up on required action steps as indicated on the report.

What is enrollment based on?

• Enrollment is based on 2022–2023 CTE course enrollment pulled from CEDARS.



CTE Verification Reports: Frequently Asked Questions

- What do I do if I have a course approved in EDS, but my report is showing the course as not approved?
 - Talk to us! We are here to help and clarify. Program Supervisors will walk you through the findings.
 Once it is determined that the report is accurate, the action typically requires correcting reporting
 errors and submitting a new course application. Recommendation: Check enrollment reported in
 CEDARS last year.
- What do I do if OSPI says we are offering a course and we are not?
 - We encourage you to check in with your registrar that codes the courses for enrollment and make sure the CIP code you are approved to offer the course for matches the course claimed in CEDARS.
- Can a course be deleted if my LEA no longer wants to offer it?
 - No. Please take action where indicated. Courses that are in pending or create status can be deleted.



CTE Verification Reports: Frequently Asked Questions

- Are we going to receive verification reports every year?
 Why now? What does the future look like?
 - Just completed the 5-year program approval cycle and in evaluating what our course and program approval system will look like in the future we need to identify what courses would transfer into a new system.
- What are next steps if a course is not approved?
 - Submit a new course application for the course you want to offer in EDS and do not claim CTE enhanced funding until it is approved by OSPI.



Apportionment: Assistance & Contact



Revise your 2022–23 P223s to report CTE FTE for classes that are approved on the monthly count day and taught by a CTE endorsed teacher within 20 school days of the count day.



Districts can make revision to their P223 up until November 27. For more information on this, please refer to the <u>Enrollment Reporting Handbook</u>.
