PURPOSE/BACKGROUND

Pandemic Electronic Benefit Transfer (P-EBT), or Pandemic EBT, is a United States Department of Agriculture (USDA) program developed in response to the COVID-19 pandemic. The program provides food benefits to eligible children to replace meals that students would have received, if not for disruptions to in-person instruction or school facility closures.

Schools play a vital role to ensure eligible Washington students receive these benefits. Pandemic EBT benefits have been issued throughout the pandemic for school year (SY) 2019–20, SY 2020–21, Summer 2021, and Summer 2022. Washington has submitted plans for Children Under Six P-EBT and Summer 2023 P-EBT which are currently under review by USDA.

With the end of the federally declared public health emergency on May 11, 2023, Summer 2023 will be the final year of P-EBT benefits. However, the Consolidated Appropriations Act of 2023 included a permanent Summer EBT program. Information about Summer EBT will be provided at a later date.

ADMINISTRATION

The Department of Social and Health Services (DSHS), in partnership with the Office of Superintendent of Public Instruction (OSPI), administers P-EBT in Washington state. Collaboration between these state agencies, local schools, and districts ensures that Washington students receive this important benefit.

We appreciate Local Education Agency (LEA) efforts to provide meals to students during the school year and as well as during the summer months. Students are eligible for summer P-EBT benefits regardless of whether they participate in summer meal programs.

P-EBT Eligibility

Students who were approved for free or reduced-price school meals in SY 2022–23 and were enrolled in June 2023 are eligible for P-EBT benefits. This includes:

 Students enrolled at a school that participates in the National School Lunch Program (NSLP) or School Breakfast Program (SBP) or students that have access to NSLP/SBP meals.

AND

- Students included in Free and Reduced-Price (F/R) eligibility for SY 2022–23 including:
 - 2022–23 Directly Certified Students through Direct Certification system
 - 2022–23 Directly Certified Students through other sources
 - 2022–23 Eligible students via new free and reduced-price meal applications

OR

 All students in schools that participate in the Community Eligibility Provision (CEP), or Provision 2 for both the NSLP and SBP, are eligible for benefits.

Students enrolled in virtual academies or other schools that do not participate in the NSLP are not eligible for benefits, unless those students are on campus at a qualifying NSLP/SBP school site for regularly scheduled, educational activities and have access to meals.

Schools should encourage eligible households to submit a free and reduced-price application if they have not already done so. Applications should be accepted and processed until the last day of the school year. Applications submitted after the last day of the SY2023 may not be accepted for Summer 2022 P-EBT benefits.

Approved Plans and Benefit Levels

Summer P-EBT benefits will be issued to all eligible students as outlined above. The benefit amount is \$120 per student and will be available on existing P-EBT cards. Newly eligible students will receive a P-EBT card in the mail. Benefits are planned to be issued in late August.

The WA Children Under Six plan was also submitted to USDA and is pending approval. Children may qualify if they are under age 6 and live in a household with an active Basic Food Assistance account. Benefit amounts will be announced on the <u>DSHS webpage</u> following plan approval from the USDA.

LOCAL EDUCATION AGENCY (LEA) ROLE

Upload Data

Information provided by LEAs is used to identify eligible students. LEAs must upload student and school information into the P-EBT portal in order for students to receive P-EBT benefits. Instructions on how to upload the information was provided to your district's designated P-EBT contact.

Data is uploaded into a secure data portal hosted by Accenture, a DSHS contracted vendor. Section 1101(e) of the Families First Coronavirus Response Act (FFCRA, P.L. 116–127) states: "Notwithstanding any other provision of law, the Secretary of Agriculture may authorize State educational agencies and school food authorities administering a school lunch program under the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq.) to release to appropriate officials administering the supplemental nutrition assistance program such information as may be necessary to carry out this section."

Data compilation and uploads must be completed by school staff that have the authority to access Meal Eligibility student information.

Communication with Families

We encourage LEAs to share this information with families through communication channels such as social media, emails, and other outreach methods. A P-EBT communications toolkit has been sent to your district P-EBT contact.

Families can sign up for text message alerts about the status of their child's P-EBT benefits by filling out a simple verification form on the <u>DSHS P-EBT Text Sign-Up webpage</u>.

Assurance of Civil Rights Compliance

Department of Justice Enforcement Guidelines (28 CFR Parts 35, 42 and 50.3); ix. Food and Nutrition Service (FNS) directives and guidelines to the effect that, no person shall, on the grounds of race, color, national origin, sex, age, or disability, be excluded from participation in, be denied the benefits of, or otherwise be subject to discrimination under any program or activity for which the Program applicant receives Federal financial assistance from USDA; and hereby gives assurance that it will immediately take measures necessary to effectuate this Agreement. x. ascertain compliance with the nondiscrimination laws. If there are any violations of this assurance, the Department of Agriculture, FNS, shall have the right to seek judicial enforcement of this assurance. This assurance is binding on the Sponsor, its successors, transferees and assignees as long as it receives assistance or retains possession of any assistance from USDA.
